# Counselling Contract

#### Bereavement Matters Offer:



- > One-to-one counselling of 50 minutes per session
- An offering of 20 sessions including missed/cancelled sessions
- Weekly sessions held at the same time and place with the same counsellor
- A confidential service in a safe, nonjudgemental and non-discriminatory environment



## Our Fee Policy:

- An initial one-off clinical assessment is charged at a standard rate of £35 or a reduced rate of £20 for those on limited income
- Weekly counselling sessions are charged at a standard rate of £35 per session or a reduced rate of £20 for those on limited income
- Payment to be made weekly by cash or cheque made payable to 'St Albans Bereavement Network'
- Missed or cancelled sessions are chargeable in full, apart from exceptional circumstances to enable a weekly session to be reserved. Counsellor's holidays or absences will not be charged
- No service user is turned away on the basis of inability to pay. Such circumstances can be funded by grants
